### ESG in the USA

#### **Executive Order on Climate-Related Financial Risk in May 2021:**

- Securities and Exchange Commission (SEC) to develop a disclosure framework for environmental, social, and governance (ESG) risks for public entities
- Climate Related Disclosure Standards pushed back to 2024
- ESG was not listed on the 2024 Examination Priorities
- SEC Investor Advisory Committee

- Local and State Regulations
